Please explain how these funds will be used to provide a public benefit:

The St George Rosenwald School is a historial building and area that also includes other builidngs, properties and sites that will be part of a upcoming tour. These African American schools are part of a more broader initiative from the Rosenwaldh school for black students after Reconstruction. This refurbishment is an ongoing process that started with the school and now is also encompassing the additional grounds, other sites and stores from the North St. George Area. These funds are used to expand the footprint of the Rosenwald school to include: lighting, memorial marker, documentation of alumni, the refurbishment of a Caboose and the outfitting of a Dining Car as well as a sound system and a shed to house an antique Ford Model T including lighting. The public can rent the facilities and there are different ongoing activitites happening at St. George Rosenwald School (SGRC). As you can see from our website, something is going on at all times. We are also partnered with the Museum of the SC Lowcountry to encourage attendance in this area also on our website.
